as follows:

ARTICLE 1.)

Pursuant to section 467 of the Real Property Law of the State of New York, the Town of Augusta, Oneida County, New York does hereby establish the following partial exemption from real property taxes for people sixty-five years of age and older based on graduated income eligibility levels between \$10,500.00 and \$16,200.00:

ANNUAL INCOME	PERCENTAGE ASSESSED VALUATION EXEMPT FROM TAXATION
Less than \$10,500	50%
More than \$10,500 but less than \$11,500	45%
More than \$11,500 but less than \$12,500	40%
More than \$12,500 but less than \$13,500	35%
More than \$13,500 but less than \$14,400	30%
More than \$14,400 but less than \$15,300	25%
More than \$15,300 but less than \$16,300	20%

ARTICLE 2.)

This local law supercedes all prior local laws establishing eligibility levels.

ARTICLE 3.)

This local law shall take effect immediately upon filing with the Secretary of State.


