After speaking with the Office of the State Comptroller, it was advised that a committee be appointed for matters concerning the Salt Barn.

This committee will consist of Highway Superintendent Eaton and Councilmen Wright and Dowd. Councilman Wright will act as chairman of the committee.

After they have come up with a plan and cost, details will be brought to the entire town board.

Supervisor Collins asked if Town of Augusta would be interested in supporting the Greater Mohawk Valley Land Bank.

Resolution of Support for the Greater Mohawk Valley Land Bank

WHEREAS, the New York State Land Bank Act, Article 16 of the New York Not For Profit Corporation Law permits local government entities to enter into intergovernmental agreements to establish a land bank; and

WHEREAS, the Counties of Herkimer, Montgomery, Otsego and Schoharie, as well as the City of Rome and the City of Utica - all Foreclosing Governmental Units (FGUs) - have entered into partnership with the Greater Mohawk Valley Land Bank and are receiving the benefits of that partnership, and

WHEREAS, there is a continuing need to strengthen and revitalize the economy of Oneida County, and

WHEREAS, it is in the best interest of the State of New York and the municipalities of the County of Oneida to confront in a coordinated manner the problems caused by vacant, abandoned, and tax-delinquent properties through partnership with the Greater Mohawk Valley Land Bank, and

WHEREAS such partnership will, over time, foster the redevelopment of blighted properties by returning them to productive use in order to strengthen the local economy, improve quality of life, and improve the financial condition of the municipalities,

THEREFORE BE IT RESOLVED, that the Town of Augusta hereby endorses the Greater Mohawk Valley Land Bank and encourages the County of Oneida to consider supporting its

local governments by partnering with the Greater Mohawk Valley Land Bank in its fight against blight.

BOARD: Councilman Ritenour asked whether the Highway Department uses Written Time Sheets or Punched Time Cards and who is monitoring the hours put on the timesheets.

Councilman Dowd gave an update in regards to the Knoxboro property.

Asbestos has been abated, awaiting on certificate for landfill use.

He wanted opinion of allowing residents to take material out of home before demolition.

Supervisor Collins reiterated that this is now Town owned property and anything that is removed from the house would have to go up for bid, allowing all residents a fair opportunity to acquire materials if wanted.

Councilman Dowd is to contact Ed Buccerio, the Towns Insurance Agent and get insurance put on this property immediately.

Councilman Dowd also mentioned that the Oriskany Falls Fire Department is interested in using the house for a training class. A Certificate of their Insurance must be obtained and kept before anyone enters the building.

Councilman Dowd stated he still has concerns regarding the reval when it come to the BAR and Grievance Day.

Supervisor Collins made a motion at 7:13 PM, seconded by Councilman Ritenour to enter into Executive Session to discuss the financial history of a particular person(s) or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person(s) or corporation and Proposed acquisition, sale or lease of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof

At 7:15 PM, the board came out of Executive Session.

With no further business, on a motion of Councilman Ritenour seconded by Councilman Dowd, the meeting was adjourned at 7:20PM. Carried unanimously.
