The level of assessment has dropped by 4%, which means that if all figures remain the same, there will be a 5.75% increase in school tax bills for 2019. He feels that a Re-assessment is needed to bring our TAV to 100% and is confident that he could keep it at a 100% value with a 1 or 2% adjustment annually. Councilman Wright asked if drone documentation would be beneficial for supporting property evidence.
