Councilman Dowd gave an update on the Knoxboro Flooding Project. The bids for the culvert project were opened and awarded, therefore work should be starting soon.

Councilman Dowd said that the Town is still awaiting a response from Tony Picente regarding the Indian Gaming Fund that was taken away from us. County Legislator Idzi has also been contacted.
