Councilman Dowd said that the Flood Mitigation Grant has been received in Albany pending review.

The Town Board is requesting from the Highway Superintendent that if there is an issue (breakdown, accident etc.) with any of the Town's trucks or equipment, that they all be notified by text, email or phone of the incident.

They are also inquiring as if to employee that was in the last incident was seen medically and whether a drug and alcohol test was performed as PESH requires.

Councilman Russell has met with Codes Officer to discuss ongoing situations. As further facts and findings are received from NY State, Codes will update status.
