## HIGHWAY SUPERINTENDENT

Highway Superintendent reported that the Snowblower and 2003 Freightliner Truck have been sold by International Auctions. He is awaiting payment in the amount of \$1775. For snowblower and \$13,400 for the Freightliner.

Highway Superintendent said there is old blades (cutting edges) that can no longer be used at the Town Garage, and he is going to try to sell them to other towns to recover some of the cost.

#### **TOWN CLERK:**

Town Board signed a monthly reconciliation sheet for the Town Clerk Checking Account, verifying that the February 2024 bank statement and checkbook were in order.

Advised Town Board that there are several Discharges of Mortgages coming due in early 2025 from the Thoma Grant. According to Oneida County, \$50.50 is charged for each filing, which falls onto the town as an expense. A copy of the filing has been given to Supervisor Collins so that she can check with Attorney Parker and verify if the format that used to process is correct one for Oneida County.

Attended a class of Charitable Gaming in NYS. If at any point, any church, organization or persons in the Town of Augusta want to hold a raffle, bingo or any gambling related event, they would be denied a license from NYS as we do not have a Local Law filed with the Commission along with an approval of filing from NYS. Clerk will look for sample copy of such law or ordinances.
